Scoping study on establishing a National Human Rights Institution for the Cook Islands

At the request of the Government of the Cook Islands, a team of 3 from Office of High Commission for Human Right/United Nations Development Program, Regional Rights Resource Team and Asia Pacific Forum came to undertake a study on the feasibility of establishing a Human rights institution for the Cook Islands. There was a cross sectional consultation of stakeholders from both Government, NGOs and civil society including the island communities on Aitutaki and Mangaia. The responses received were both for and not in favor of the establishment with reasons given.

Community-Based Rehabilitation (CBR) - Tonga

A follow-up regional workshop on progress of CBR for the Polynesian countries was held in Tonga in April 2017.

The workshop provided a model to help strengthen Pacific Island governments in promoting, protecting and fulfilling the rights of person with disabilities as outlined in the CRPD. The Cook Islands was represented

by Mr Mataiti Mataiti, President of Cook Islands National disability Council, Donna Smith—Te Vaerua Community Rehabilitation Organization and Pauline Rangi from Ministry of Internal Affairs, Cook Islands.

A follow up of actions is envisaged of the team to conduct in order to ensure CBR is effectively continued in the Cook Islands.

CIFWA & Disability Family Planning workshop—Samoa 9-13 July 2017

The International Planned Parenthood Federation (IPPF) through the Pacific for Health (DFAT) program, conducted a training on Disability Inclusion and Sexual Reproductive Health education program in Samoa. Ms Tangi Ngere Clinic Service Nurse from Cook Islands Family Welfare Association (CIFWA) & Ms Pauline Rangi from Ministry of Internal Affairs attended the workshop. Hosted by the Samoa Family Planning Unit

(FPU) and facilitated by Jane Chivers & Helen Smith of Family Planning Australia. Samoa's FPU shared about the success of their outreach programs that has reached a lot of people in the community who has less access to Health care, education and employment. Another important subject of the workshop was on the human rights perspective of disability. These include, the Social model of disability, barriers to an inclusion and enabling

environment. Approaches would include effective communication, inclusion in a Humanitarian setting and planning inclusive services. The Cook Islands participants looks forward to work together to apply the knowledges gained from the workshop in their work plans and activities.

The Senior Adviser for Disability has been involved in a number of meetings with line ministries of government. The purpose of these meetings were to address the issue of disability in institutional policies, reports and programs.

I. Draft National Building Code— It has been over two decades when the National Building Code was enacted and there were requests made in the past to review it to align with the building standards of today. We are grateful to Infrastructure Cook Islands who had taken the initiative along with external support from New Zealand Volunteer services to carry the tasks of reviewing the Code.

The Ministry of Internal Affairs was consulted during the review process and the Disability office contributed to the review focusing on Accessibility (CRPD Article 9) and Disability Act Part 4 Access to Buildings. In order to enjoy a barrier free society, government must take necessary actions to ensure persons with disabilities have access to the physical environment, transportation etc on an equal basis with others ensuring that 'no one is left behind' in the tribe. The office is grateful that access to building by persons with disabilities is recognized in the code which forms Part ND3, Access to Buildings of the final Building Code.

2. Labour laws scoping exercise— A scoping exercise was conducted by the ILO Pacific office to examine the progress of the Cook Islands in compliant with the five ILO Conventions that the country has ratified. Amongst the number of government ministries, the Disability office was consulted in relation to persons with disabilities in employment.
